# WHAT IS THE ADAMH BOARD?

Ohio Law created alcohol, drug addiction, and mental health boards to ensure that services and facilities are available for the treatment of people who have alcohol, drug addiction, and/or mental health problems.

The Gallia-Jackson-Meigs Alcohol, Drug Addiction and Mental Health (ADAMH) is one of 50 boards across Ohio. These boards are statutorily empowered to plan, develop, fund, manage, and evaluate community-based mental health and addiction, treatment, and prevention services.

The Board works within our local community to determine what is needed in drug, alcohol, and mental health services. Contracts with provider agencies for direct services to residents in Gallia, Jackson, and Meigs counties.

# **OUR VISION**

Residents of Gallia, Jackson, and Meigs Counties are provided a culturally appropriate and stigma-free system of mental health and addiction education, prevention, treatment, and recovery services that are available and accessible to each individual in need.



# **OUR MISSION**

It is the mission of the Gallia-Jackson-Meigs ADAMH Board to serve as the behavioral health authority for the area; supporting and improving the quality of life for residents by developing and maintaining a coordinated system of accessible mental health and addiction advocacy, education, prevention, treatment, and recovery supports.



## **OUR BOARD & STAFF**

Under Chapter 340.02 of the Ohio Revised Code, fourteen citizens of Gallia, Jackson, and Meigs counties are appointed to serve on the Board. The Director of the Ohio Department of Mental Health and Addiction Services (OhioMHAS) shall appoint six members. The remaining 8 members are appointed by county commissioners.

# NATIONAL 988 SUICIDE AND CRISIS LIFELINE LAUNCHES IN OHIO

On July 16, 2022, the National Suicide Prevention Lifeline (1-800-273-8255) transitioned to the 3-digit 988 Suicide & Crisis Lifeline. Ohioans who are experiencing a mental health or addiction crisis, and their family members, are now able to call, text, or chat 988 in order to reach a trained call specialist who can offer help and support.

The easy-to-remember, 3-digit number will provide greater access to life-saving services, and the Ohio Department of Mental Health and Addiction Services (OhioMHAS) continues to work with federal, state, and local partners and stakeholders to ensure the implementation of 988 is successful across the state.

Ohio's 988 plan is part of the state's larger commitment to providing quality, person-centered crisis supports in communities across the state.

### Mental Health and Addiction Emergency or Crisis?

#### Mental Health and Addiction EMERGENCY

A mental health and/or addiction emergency is a life-threatening situation. An immediate response from law enforcement or medics is needed. A person may be actively trying to harm themselves or someone else. In other situations, a person may be out of touch with reality, be unable to function properly, or may be out of control.

Examples of mental health and addiction emergencies are:

- Active suicide threat.
- · Threatening harm to self or others.
- Self-injury that needs medical attention.
- · Severe intoxication.
- · Inability to care for oneself.
- Apparent drug overdose.

If someone is having a mental health and/or addiction emergency, CALL 911.

What to expect when you call 911:

- A dispatcher will answer your call and ask about your emergency.
- Local law enforcement or paramedics will be sent to your location.
- In some cases, a crisis intervention team will accompany law enforcement.
- You will get help dispatched immediately.
- You may be transferred to 988, if appropriate.

#### Mental Health and Addiction CRISIS

A mental health and/or addiction crisis is not a life-threatening situation. Intervention may be possible without an immediate response by law enforcement or medics. A person may be thinking about hurting themselves or someone else or may be extremely emotionally upset or distressed.

Examples of a mental health and addiction crises are:

- Talking about suicide or planning to harm oneself.
- · Talking about harm to self or others.
- Self-injury that doesn't need immediate medical attention.
- Overuse of alcohol or other drugs.
- Extreme depression, anxiety, or other mental illness symptoms.

If someone is having a mental health and/or addiction crisis,

CALL 988.

What to expect when you call 988:

- · A trained professional will answer your call.
- The professional will ask you to describe your crisis.
- In many cases, the professional will assist you over the phone and link you to additional care as necessary.
- In some cases, a mobile team will be sent to your location.
- If necessary, the person experiencing a crisis will be taken to a stabilization facility.
- You may be transferred to 911, if needed.

Families with youth and young adults between 0 to 21 who are experiencing difficulties or distress can receive assistance from the MRSS Team. The MRSS team meet with youth and families in person wherever they are. All services are provided in a trauma informed way and utilize family systems intervention. Families can stay with MRSS for up to 60 days. Call for assistance 24 hours a day, 7 days a week.

# MENTAL/BEHAVIORAL HEALTH & ADDICTION DESCRIPTIONS

#### **Alcoholics Anonymous (AA)**

Alcoholics Anonymous is an international fellowship of men and women who have had a drinking problem. Membership is open to anyone who wants to do something about his or her drinking problem.

#### **Ambulatory Detoxification**

Face-to-face interactions with an individual who is suffering mild to moderate symptoms of withdrawal, for the purpose of alcohol and/or drug detoxification.

#### **Assessment**

The evaluation of an individual to determine the nature and extent of his/her mental illness and/or abuse, misuse, and/or addiction to alcohol and/or other drugs.

#### **Case Management**

Activities provided to assist and support individuals in gaining access to needed medical, social, educational, and other services essential to meeting basic human needs.

#### **Community Psychiatric Supportive Treatment (CPST)**

Provides a number of services delivered by community-based, mobile individuals or multidisciplinary teams of mental health care professionals and trained others. Services address the individual needs of clients and focus on an individual's ability to succeed in the community; identify and access needed services, and show improvement in school, work, family, and contributions to the community.

#### **Diagnostic Assessment**

Is a clinical mental health and/or substance misuse evaluation provided by an eligible professional at the beginning of treatment or in response to treatment, or when significant changes occur. It is a process of gathering information to assess client needs and functioning in order to determine appropriate service/treatment based on the identification of the presenting problem, evaluation of mental status, and formulation of a diagnostic impression.

#### **Education/Consultation/Prevention Services**

Education services indicate formal educational presentations made to individuals or groups that are designed to increase community knowledge of and to change attitudes and behaviors associated with mental health and addiction problems, needs, and services. Consultation services are formal and systematic information exchange between an agency and a person other than a client, which is directed towards the development and improvement of individualized service plans and/or techniques involved in the delivery of mental health services. Finally, prevention services indicate action-oriented programs either toward reducing the incidence, prevalence, or severity of specific types of mental illness and/or addiction disorder.

#### **Emergency Services**

Includes both Crisis Intervention & Behavioral Health Hotline services. Crisis intervention is the process of responding to emergent situations and may include: assessment, immediate stabilization, and the determination of the level of care in the least restrictive environment in a manner that is timely, responsive, and therapeutic. Behavioral health hotline services are an agency's twenty-four-hour-per-day, seven days per week capability to respond to telephone calls, often anonymous, made to an agency for crisis assistance. The person receiving emergency services may or may not become a client of the agency providing these services. These services are usually rendered face-to-face at a person's home, at a mental health agency, or via telephone.

#### **Employment/Vocational Service**

Is to promote recovery and secure/maintain employment by providing training and skill development that is goal-oriented, ability-based, and incorporates individual choice. The outcome of employment/vocational service is that the individual will obtain Mental/Behavioral Health and Addiction Service Descriptions 6 and maintain employment, learn new job skills, increase self-sufficiency, and contribute to the community.

#### **Family Counseling**

The utilization of special skills in sessions with individuals and their family members and/or significant others under the guidance of a counselor to address family and relationship issues related to mental health, alcohol and other drug abuse and/or dependence for the purpose of promoting recovery from addiction.

#### **Forensic Evaluation Services**

An evaluation resulting in a written expert opinion regarding a legal issue for an individual referred by a criminal court, domestic relations court, juvenile court, adult parole authority, or other agency of the criminal justice system or an Ohio Department of Mental Health and Addiction Services (OhioMHAS) operated regional psychiatric hospital. Forensic evaluation service also assists courts and the adult parole authority to address mental health legal issues.

#### **Group Counseling (Therapy)**

Services are typically provided through a counselor-client therapeutic relationship in which special skills are utilized to assist the client with mental illness and/or alcohol and other drug problems to achieve treatment objectives. Treatment occurs in a group setting with two or more individuals/clients facilitated by one or more counselors.

#### **Housing/Residential Services**

These are considered "other" mental health and/or substance misuse services which support persons/clients with mental illness to find affordable residential living placements and/or to assist in meeting their physical need for shelter.

#### **Individual Counseling**

Same as group counseling except treatment occurs in an individual setting, a counselor and one client only. Information, Screening & Referral Services – Includes responses, usually by telephone, to inquiries from people about services in the community. Referrals may include contacting an agency or a provider in order to secure services for the person requesting assistance.

#### **Intensive Outpatient**

Structured individual and group alcohol and drug addiction activities and services that are provided at a certified treatment program site for a minimum of eight hours per week with services provided at least three days per week.

#### **Medical or Medication/Somatic (Psychiatric Services)**

A pharmacologic management service is a psychiatric/mental health/Medication Assisted Treatment (MAT)/medical intervention used to reduce/stabilize and/or eliminate psychiatric symptoms and/or the impact of substance misuse on individuals with the goal of improved functioning. These services should result in well[1]informed individuals and in decreased/minimized symptoms.

#### **Medication Assisted Treatment (MAT)**

The services of a medical professional directly related to the use of medications to provide a whole patient approach to the treatment of substance abuse disorders.

#### Narcotics Anonymous (NA)

A nonprofit fellowship or society of men and women for whom drugs had become a major problem. Membership is open to anyone who has the desire to stop using drugs.

#### Nar-Anon

This is a family groups primarily for those who know or have known a feeling of desperation concerning the addiction problem of someone very near to you

#### Non-Medical Community Residential Treatment

A twenty-four-hour rehabilitation facility, without twenty-four-hour-per-day medical/nursing monitoring, where a planned program of 7 professionally directed evaluation, care and treatment for the restoration of functioning for persons with alcohol and other drug problems and/or addiction occurs.

#### **Outreach**

A planned approach to reach a target population within their environment. The purpose of this approach is to prevent and/or address issues and problems as they relate to the use/abuse of alcohol or drugs.

#### Partial Hospitalization/Day Treatment

An intensive, structured, goal-oriented, distinct and identifiable treatment service that utilizes multiple interventions that address the individualized mental health and/or addiction recovery needs of a client. The environment at this level of treatment is highly structured, and there should be an appropriate staff-to-client ratio in order to guarantee sufficient therapeutic services and professional monitoring, control, and protection of the identified client.

#### Peer Recovery Services (Peer Support)

Community-based services for individuals with a mental illness or substance use disorder; and consist of activities that promote recovery, self[1]determination, self-advocacy, well-being and independence. Peer recovery services are individualized, recovery-focused and based on a relationship that supports a person's ability to promote their own recovery.

#### **Non-Medical Community Residential Treatment**

A twenty-four-hour rehabilitation facility, without twenty-four-hour-per-day medical/nursing monitoring, where a planned program of 7 professionally directed evaluation, care and treatment for the restoration of functioning for persons with alcohol and other drug problems and/or addiction occurs.

#### **Outreach**

A planned approach to reach a target population within their environment. The purpose of this approach is to prevent and/or address issues and problems as they relate to the use/abuse of alcohol or drugs.

#### Partial Hospitalization/Day Treatment

An intensive, structured, goal-oriented, distinct and identifiable treatment service that utilizes multiple interventions that address the individualized mental health and/or addiction recovery needs of a client. The environment at this level of treatment is highly structured, and there should be an appropriate staff-to-client ratio in order to guarantee sufficient therapeutic services and professional monitoring, control, and protection of the identified client.

#### Peer Recovery Services (Peer Support)

Community-based services for individuals with a mental illness or substance use disorder; and consist of activities that promote recovery, self[1]determination, self-advocacy, well-being and independence. Peer recovery services are individualized, recovery-focused and based on a relationship that supports a person's ability to promote their own recovery.

#### **Social & Recreational Services**

Includes structured and non-structured activities and supports to enhance the quality of life of the person served. These services occur, whenever possible, in facilities used for social and recreational purposes by other members of the community.

#### **Subacute Detoxification**

Detoxification services are provided with twenty-four-hour medical monitoring.

#### <u>Urinalysis</u>

The testing of an individual's urine specimen to detect the presence of alcohol and other drugs.

#### **12-Step Program**

Developed by Alcoholics Anonymous, it is a 12-step plan in order to overcome addictions and compulsions. The basis of this model is that people can help one another achieve and maintain abstinence from substances of abuse or compulsions. While recognizing that healing cannot come about unless people with addictions surrender to a higher power.

The mission of Cardinal Recovery, LLC is to provide the people of Gallia County and surrounding areas, quality alcohol and drug abuse/addiction treatment services which will include, but not be limited to: Residential and Outpatient services to include but not limited to General Services, Withdrawal Management, Crisis Intervention and SUD Case Management Services

#### **Relapse Prevention**

The relapse prevention program includes a self- assessment for clients to ascertain how well they are preventing relapse. The program will cover topics such as Treatment Attitudes, Recovery Behaviors, Common Recovery Dilemmas and Protracted Withdrawal.

#### **Cognitive-Behavioral-Interventions for Substance Abuse**

The curriculum is designed for individuals that are moderate to high need in the area of substance abuse and well suited for criminal justice populations. This intervention relies on a cognitive behavioral approach to teach participates strategies for avoiding substance abuse.

#### Living in Balance

Updated to meet DSM-5 classifications, this flexible program draws from cognitive-behavioral, experiential and Twelve Step approaches to help clients achieve lifelong recovery. This program is ideal for a variety of settings and is extremely comprehensive and customizable. Clients can join the treatment process at any point in the program delivery.

#### **12-Step Facilitation**

Clients will be introduced to the 12 steps of recovery. The program merges material from both NA and AA into a comprehensive guide. It discusses each step and asks clients questions designed to ascertain their willingness to delve deeper into that step and their recovery.

#### Withdrawal Management

Cardinal Recovery, LLC has withdrawal management/detox services. Our detox facility can accommodate 11 clients, both men and women.

#### Men's Inpatient Treatment Facility

Since 2016, Cardinal Recovery, LLC has a men's inpatient treatment program, located on Jackson Pike in Gallipolis, which can accommodate up up to 16 clients at one time. Our facility also has a classroom designed for daily group counseling, living and dining area, kitchen and laundry room.

It is Cardinal Recovery, LLC's focus to provide each client with a comfortable and well-maintained living environment.

Services Offered for Men's Inpatient Substance Abuse Treatment

- Case Management: This service is offered to assist clients with mental health and/or medical appointments, court appearances, transportation and post treatment basic needs such as housing and employment.
- Life Skills: This will be utilized to strengthen client's basic life skills in areas such as cooking, budgeting, resume building, etc.
- Health and Wellness: Keeping in line with Cardinal Recovery's holistic approach to treatment, every client will be offered a chance to routinely work on their physical health by working out at The Warehouse Gym.
- In House Meetings: Members of the recovery community will be volunteering their time to "bring a meeting in" to the residents.
- Outside Meetings: Clients will be transported and accompanied by staff to outside AA and NA meetings throughout Gallia County.

Field of Hope is a 501(c)3 non-profit organization registered with the state of Ohio and the federal government. Our staff and facilities are certified to perform the services we offer to help others get victory over alcohol or drug addiction. The strong FOH organization has excellent clinicians available for counseling. Our residential house managers are also certified and trained in counseling, first aid, CPR, and all necessary emergency procedures. They work on a rotating shift to cover the residential treatment houses 24/7.

Every treatment/counseling organization has a basic philosophy of treatment. The FOH is Christian faith-based on our approach to life change. Clinicians utilize an evidenced-based curriculum and person-centered therapy in treatment. We offer opportunities to engage in 12-Step related activities, community involvement, as well as life and job skills training. The FOH has faith partners and supporters — other churches, businesses, and civic organizations. The vision of FOH was born at Vinton Baptist Church. They continue to be a primary supporting organization.

#### **IOP / Outpatient**

- It is not a requirement to reside in a Field of Hope Sober Living house to attend IOP/OP (Intensive Outpatient and Outpatient) services. The main difference between the two is the hours of services provided. IOP consists of 9-19 hours of service that include groups, individuals, and case management if needed. Under 9 hours of service is considered Outpatient. Outpatient participants will also have 1-3 days of group therapy, an individual session, and case management if needed. Our IOP/OP groups occur Monday through Friday from 9:00 am to 11:00 am.
- To begin IOP/OP services, you must first complete a comprehensive assessment.

#### **Women's Inpatient Treatment (Hope House)**

Many begin their recovery journey at the Hope House for inpatient treatment. The Hope House provides a safe place for those who need removal from current environmental stressors that include triggering people, places, and things. This time allows participants to focus on themselves and gives them the ability to cultivate more healthy coping skills without outside distractions.

#### PHP / Reentry (Faith House)

Women who have at least 30 days of sobriety may be eligible to be admitted straight into our ON-Campus Sober Living house. This step down from inpatient, which we refer to as the Faith House, provides structured programming to allow time to prepare a solid recovery foundation before placement in the Sober Living OFF-Campus.

The structure and accountability provided for Sober Living ON-Campus participants begin the process of reintegration back into society as sober and drug-free people. By the time participants move to the OFF-Campus Sober Living house, the employment process will have already begun and a schedule to support sobriety will be in place.

#### **Sober Living**

Those who have completed PHP are eligible to move into our OFF-Campus Sober Living. Our Sober Living that is located off-campus provides the time participants need to identify roadblocks that may occur in recovery. As situations present themselves, participants will have the opportunity to work with caring staff to devise a plan of action. Participants coming from the Faith House will move to Sober Living off campus once they are transferred to IOP (Intensive Outpatient). At this point, if a job has not already been found, a more intensive employment search will be implemented if it is in the treatment plan to do so. Case Management services will increase as preparation is made for independent living.

#### **Mental Health Services**

Serving adults, teens, and children, Field of Hope provides trauma-specific therapy as well as individual, family, and couples mental health counseling. For individuals receiving mental health services at Field of Hope, a psychiatric nurse is available to provide additional psychiatric medication support.

#### **Prevention**

Field of Hope Community Campus is a certified prevention center through the Ohio Department of Mental Health and Addiction Services (OMHAS) that offers prevention and counseling services to the youth in Gallia County and surrounding areas. These services help educate and empower children, teens, and families to reduce risky behaviors and promote positive change. The programs are interactive, fun, and educational. They are available within the local schools and community venues, making them easily accessible for the youth and their families. Like all other programs that the Field of Hope offers, our prevention services are faith and evidence- based.

To those adults, adolescents, seniors and families suffering from the diseases of substance use and/or mental health disorders. HRS is dedicated to offering the services they need to fight the epidemic of addiction and despair that plagues them. Our commitment to serve stems from a core belief system that affirms all are deserving of quality prevention, intervention, treatment and aftercare, regardless of race, color, sex, national origin, disability, age, gender identity, sexual orientation, religion and ability to pay. Consumers are encouraged to meet their financial obligation for services under a sliding fee scale so that the limited community resources can be stretched to help as many less fortunate consumers as is possible. The HRS philosophy of care and mission is to make sure those we serve know that we care, because only then will they care about what we know.

#### **Programs**

#### **Gallia Outpatient**

Currently has several programs available for the community. Licensed and/or credentialed counselors provide assessment and treatment services using evidenced based practice such as the Motivational Interviewing Treatment Approach and the Community Reinforcement Approach.

#### **Motivational Interviewing**

Approach assists participants in increasing their awareness of the problem and the solution. Participants of Motivational Interviewing reinforces preparation to change, action and maintenance behavioral change. This approach has proven successful in working with a variety of populations who present a range of issues in the clinical arena, in particular, substance abuse and addiction.

#### **Psychological Diagnostic Evaluation**

It is the first stage of intervention with persons whose substance use or behavioral health issue has a negative impact on his or her life. A comprehensive appraisal of the individual's alcohol or drug use, gambling and mental health, and how it affects his or her health and functioning, is vital for selecting treatment resources that best meet his or her needs. Psychological Diagnostic Evaluation includes a determination of many factors, including the severity of the problem, possible influences that have perpetuated chemical use/behavioral issues, related difficulties; and the individual's perceptions of and attitude toward treatment. Other related factors such as needs for physical healthcare, housing, educational services, etc. are identified and addressed through this process as well.

#### **Individual Psychotherapy**

Provide substance abuse/dependency, gambling and mental health psychotherapy to increase understanding and responsibility surrounding behavioral choices related to substance abuse and mental health issues.

#### **Group Psychotherapy**

Provide participants the ability to evaluate and identify the progressive nature, signs, stages and symptoms of addiction in their own lives. Provide the exploration of alcohol and other drug problems and/or addiction and their ramifications, including an examination of attitudes and feelings, consideration of alternative solutions and decision making and/or discussing information related to alcohol and other drug related problems. Participation and attendance in the group are mandatory and will assist the consumer to begin experiencing personal growth towards recovery.

#### **Medication Assisted Treatment**

Provide research based practices to treat various forms of addiction. Medication Assisted Treatment (MAT) is the use of medications in combination with psychotherapy and behavioral therapies for the treatment of substance use disorders. A combination of medication and behavioral therapies is effective in the treatment of substance use disorders, and can help some people to sustain recovery. On-site daily medication administration is available.

#### Withdrawal Management On-site Monitoring

HRS withdrawal management is an in-person interaction with a person suffering from mild to moderate symptoms of withdrawal from opioids. It is a service that is medically supervised by HRS physicians, nurses, and clinicians. Every individual meeting basic referral criteria for withdrawal management will receive a comprehensive physical psychological diagnostic evaluation, nursing evaluation, and phlebotomy testing. Those completing the withdrawal management program (including group and individual sessions with nursing and medication administration for approximately 2 weeks) may be referred for additional Medication Assisted Treatment (as deemed appropriate) and for individual/group psychotherapy to address the causes of addiction and to enhance the skills needed to maintain abstinence. Clients are required to be compliant with ALL aspects of the withdrawal management program to remain in the program.

#### **Psychotherapy for Crisis**

Provide assistance with a client that is in response to a crisis or emergency situation experienced by themselves, a family member and/or significant other. It includes an evaluation of what happened during the

crisis and the individual's response or responses to it. Information about the individual's strengths, coping skills, and social support networks is also obtained.

#### **Alcohol/Drug Laboratory Testing**

Health Recovery Services, Inc. holds a contract with a nationally recognized laboratory to conduct the laboratory urinalysis testing for presence of alcohol and or other drug substances.

#### **Case Management**

To provide assistance and support to individuals in gaining access to needed medical, social, educational and other services essential to meeting basic human needs. Case management services may include interactions with family members, other individuals or entities and significant other including such as parole officers, teachers. It is to assist individuals with utilizing strengths and resources to acquire necessary skills and services to increase independence.

#### **Information and Referral**

To provide information or to refer individuals, families, or communities to agencies that can help with issues such as mental health psychotherapy, education, family services, legal services, government agencies and more.

#### Intervention

Provide brief screening to detect alcohol and/or other drug problems and addiction and to intervene in such a way as to arrest the progression of such problems.

This location is dedicated to creating lasting family connections for family support Programs offered vary from mental health group/individual counseling to anger management courses and criminal justice system support.

#### Jackson County Southern Ohio Treatment Center (SOTC)

The Southern Ohio Treatment Center (SOTC) Medication Assisted Treatment (MAT) Program is a certified Opiate Treatment Program/Narcotics Treatment Program (OTP/NTP). SOTC provides both Substance Abuse and Mental Health treatment services. SOTC provides a full range of adult, community-based consumer and outcomes focused behavioral healthcare services.

#### **Women's Outreach**

The Women's Outreach Program provides FREE education, intervention and referral services to females of all ages and their families. Services include confidential one-on-one sessions, group sessions and presentations

for community agencies, groups, clubs and organizations. The goal is to educate the community about substance abuse; reduce the incidence of alcohol, tobacco and other drug (ATOD) abuse; reduce the stigma associated with chemical dependency; identify individuals who have indulged in illegal or age inappropriate use of ATOD; promote recovery and wellness; and to provide social service referrals and improve access for women to treatment.

#### **Gambling Education & Treatment**

Health Recovery Services currently has 8 staff members who have completed several of the Phases of Gambling trainings offered by ODADAS, the Lottery Commission and the Ohio Council for Problem Gambling. Recruitment for the program begins with consumers who enroll in AoD treatment at Health Recovery Services' Outpatient sites. Services are also provided in the communities through the use of advertising and educational opportunities. Each customer will complete a South Oaks Gambling Screen. Those identified in the screening process as having or being at risk for gambling problems by scoring a 3 or higher on the SOG screening, will be offered further education and treatment. The ultimate goal of treatment is abstinence from gambling activities. Customers will also be offered help and referrals to assist them with money problems from losses due to gambling including, debt counseling, budgeting, and money management education. Health Recovery Services offers a variety of parenting and family strengthening programs through its Division of Community Services. Customers in treatment for gambling will be given information on these programs when appropriate.

#### vSAAMCO (Virtual Substance Abuse Assessment For Municipal Court Offenders)

2009 ODADAS Exemplary Prevention Program Award Winner. The Substance Abuse Assessment for Municipal Court Offenders Program is a research-based alcohol and drug education program for individuals charged with an alcohol and/or drug related violation. The SAAMCO program is an online 4-hour program.

#### **DOT/DAP Department of Transportation Return to Work Program**

Services available: Evaluation, Individualized Service Plan (ISP), Referral, Follow-up evaluation, Testing plan, Letter of compliance. All Return to Work services are provided by a Substance Abuse Professional (SAP) as required by Department of Transportation Regulations

#### **Drug Free Workplace**

This program offers a full array of technical assistance services for agencies/companies that are considering or have made the decision to implement a Drug Free Safety Program (DFSP). Each program is individualized therefore costs and benefits will vary by needs.

#### **Teacher In-service and Community Professional Training**

Trainings are available in research based and specialized programs instructed by our certified prevention trainers. Programs may be tailored to meet your needs.

#### Teen Institute Ongoing Groups and Youth Leadership Academy (YLA)

Teen Institute (TI) is a positive peer prevention program geared toward youth in grades 6-12. Technical assistance for school groups ranges from participating in regular TI meetings to scheduling speakers once per month, to providing educational materials and programming ideas as requested. Meeting schedules are arranged to meet the needs of each school. Weekly or bi-monthly meetings are recommended. We also recommend an advisor from each school assist in conducting the group.

The weekend Teen Institute YLA is a multi-county event for TI student leaders throughout Southeastern Ohio. Both Junior High and High School students receive education in substance abuse prevention theory and strategies, team building, organizing and leadership. They take part in informative workshops on topics such as decision-making, alcohol/drug resistance skills and positive lifestyle choices

#### **Red Ribbon Week Activities**

The Red Ribbon Campaign is a weeklong series of events (but is often extended over a longer period) designed to encourage students, educators, other school personnel and community members to demonstrate their commitment to a drug- free lifestyle. A wide range of activities can be included in the campaign, such as school assemblies, classroom presentations, drug-free dances, distribution of educational materials, poster contests, rallies and sporting events.

#### **School Presentations**

These one-time educational programs are presented by trained HRS staff members and can cover a variety of substance abuse issues including use, abuse and addiction; youth and adult prescription drug abuse; opiates; inhalants; methamphetamine/club drugs; oxycontin; dysfunctional families; healthy choices for young people; peer pressure; tobacco use prevention; marijuana facts; and evaluating alcohol and tobacco advertising, among others. The program length and audience size can be tailored to meet individual needs.

#### **Drug-Free Rallies Dances**

HRS supplies the sound system and light show, an extensive contemporary music collection, and entertaining emceeing in a healthy, drug free setting. No songs with explicit lyrics or lyrics that encourage violence, drug use or other unhealthy behaviors are played. Cost: \$100.00/hour. Some HRS sponsored dances may be available free of charge.

#### Parent/Family Program: Strengthening Families Program (SFP)

The Strengthening Families Program is a 7- session, science-based parenting skills, children's life skills, and family life skills training program specifically designed for high-risk families.

#### **Mentoring Program**

The Mentoring program utilizes community volunteers to form supportive bonding relationships with middle school- aged youth. It provides positive adult role models who promote the value of education and a drug-free lifestyle. It also educates young people about life skills, decision making and goal-setting, giving them the opportunity to achieve success.

# Alcohol, Tobacco, and Other Drug Prevention Programs (Class size requirements vary based on programs)

#### **Too Good for Drugs and Violence**

Too Good for Drugs and Violence Skill development is at the core of Too Good for Drugs, a 10-session universal prevention program designed to mitigate the risk factors and enhance protective factors related to alcohol, tobacco, and other drug (ATOD) use. The program introduces and develops social and emotional skills

for making healthy choices, building positive friendships, communicating effectively, and resisting peer pressure.

#### **Project Alert**

Project Alert is a school-based curriculum designed to reduce substance use among middle school students. It is delivered to seventh grade students, with booster sessions delivered in the eighth grade. Project ALERT aims to teach children to establish no-drug-use norms, to develop reasons not to use drugs, and to resist prodrug pressures.

#### **Life Skills Training**

LifeSkills Training (LST) is one of the most highly rated, recommended and researched school-based substance abuse prevention programs today. It is uniquely designed, proven effective, and grounded in over 20 years of research. Rather than simply teaching information about drugs, LifeSkills combats the underlying causes of substance use. The LifeSkills program is designed for elementary to junior high/middle school students.

#### **BABES Presentations**

The Beginning Alcohol and Addictions Basic Education Studies is a primary prevention program designed for children ranging from preschool-grade 12, with emphasis on younger children. This program helps young people develop positive living skills by providing them with age-appropriate information about peer pressure, self-image, and decision-making, especially concerning the use of alcohol and other drugs.

#### **Prime for Life**

Prime for Life is an evidence-based, risk-reduction program from the Prevention Research Institute. The first goal of the program is to help each participant develop the skills necessary to make low-risk choices regarding alcohol and other drug use.

#### **Reconnecting Youth**

Reconnecting Youth (RY) is a proven, award-winning program that helps high-risk youth achieve in school and decrease drug use, anger, depression, and suicidal behavior.

#### **Why Try**

The Why Try Program helps adolescents gain insight into how to deal with life's daily pressures and challenges. The goal of the Why Try Youth Program is to help adolescents answer the question "Why try in life?" when they are frustrated, confused, or angry with life's pressures and challenges.

#### **Internet Safety Program**

E SAFE is a one-session multimedia internet safety program for youth and adults. This progressive program goes way beyond simple virus protection. It teaches children how to protect themselves from predators and bullies online as well as protection from identity theft starting at a young age.

#### Nicotine/Vaping Intervention Program (NIP)

NIP is a program designed as a positive alternative to suspension for students caught vaping or using nicotine on school property or at school-sponsored activities.

#### Vaping/Nicotine Prevention Program

Research-based prevention presentations that address the health risks of vaping, cigarettes, smokeless tobacco and other forms of nicotine use. Program can be provided in 1 to 4 classroom periods or as a 45-minute assembly.

#### **Anti-bullying and Violence Prevention Program**

Safe Dates Highly engaging and interactive, Safe Dates helps teens recognize the difference between caring, supportive relationships and controlling, manipulative, or abusive dating relationships.

#### Second Step

Second Step: A Violence Prevention Program is a classroom-based social skills curriculum for students from preschool through middle school. The curriculum aims to reduce impulsive and aggressive behaviors and increase protective factors and social-emotional competence.

#### **Steps to Respect**

The research-based Steps To Respect program is a companion piece to the Second Step curriculum. It teaches elementary students to recognize, refuse, and report bullying, be assertive, and build friendships.

Our philosophy is simple. We believe that the best approach to wellness involves treating both the body and the mind. That's why we offer a wide range of primary care, behavioral health, and prevention programs and services. Whether you need medical, dental, or behavioral health care, our caring staff is here to help you.

#### **Dentistry**

HHC offers a full range of dental services at our Gallia Meigs, Vinton, Perry, Ross, and Nelsonville clinics.

#### **Primary Care**

Available in Athens, Gallia, Hocking, Jackson, Meigs, Perry, Ross, and Vinton Counties

HHC offers high-quality primary care services for everyone, regardless of their ability to pay.

#### **Pharmacy Services**

HHC offers both clinical and retail pharmacy services for its patients. There is a retail pharmacy in the Logan Primary Care clinic accessible to all HHC patients. Pharmacists are available to consult with all providers and patients of HHC.

#### **Behavioral Health Services**

Available in Athens, Gallia, Hocking, Jackson, Meigs, Vinton, and Washington Counties

#### **Community Psychiatric Supportive Treatment Services**

For adult consumers who experience severe mental illness, child consumers who experience severe emotional disturbances, or any consumer in a psychiatric crisis and at risk for psychiatric hospitalization, CPST services (once called "case management") are available. These services may be home, community or office-based, depending on the needs of the consumer. Assistance with accessing needed community resources, including entitlements, housing, and medical care, learning adaptive daily living skills, and understanding and living with a mental illness are all part of CPST services. CPST providers assist the consumer with treatment planning and crisis management. Communication and linkage with family members and significant others (with client permission) are also important parts of CPST Service. CPST services differ depending upon the needs of he consumer. CPST providers are advocates and brokers of services. Their goal is to help the client maximize his/her own potential and live productively in the community.

#### **Outpatient Counseling Services**

Diagnostic assessment, individual, group, family, and marital counseling are available as needed. Services are can be brief and solution-focused in nature. Our goal is to assist our clients in identifying and mobilizing their own coping skills and natural support as well as learning new skills and ways of dealing with their environment. The goal of treatment is the enhancement and development of skills to enable the client to engage in effective problem solving. Not all situations lend themselves to brief treatment, and we attempt to provide appropriate and effective, as well as cost-effective, services to all individuals. HHC has counselors who are specially trained to deal with trauma, including physical and sexual abuse. Groups are also available to help clients develop skills in areas such as anger management, abuse recovery, relationships, and coping skills.

#### **Crisis Services**

Crisis intervention and hospital prescreening services are available face-to-face or by phone (as appropriate) 24 hours a day, 365 days a year. Crisis Intervention Team workers evaluate individuals in psychiatric crisis and enable them to receive appropriate services (e.g., hospitalization, crisis residential services, safety planning, CPST or outpatient counseling.). Crisis Services can be accessed during work hours through agency facilities (during office hours), local jails and local Emergency Rooms. Crisis can be reached 24 hours a day through the Crisis Services telephone line 1-800-252-5554 or 1-888-475-8484 or 988

#### **Youth Crisis Services (Not yet opened)**

The youth crisis center will provide trauma-focused interventions to regulate emotions and behaviors, reframe the youth's thought processing, enhance support systems available to them, and rejoin them in their Community quickly. As a short-term residential facility, the time span of 3 to 14 days. the unit houses 16 beds, prepared to provide a space of retreat and refuge for both male and female youth of the ages 8-17 years old. #### **Mobile Response & Stabilization Services (MRSS)**

Available in Hocking, Jackson and Vinton Counties. MRSS stands for Mobile Response & Stabilization Services (MRSS). Families with youth and young adults between 0 to 21 who are experiencing difficulties or distress can receive assistance from the MRSS Team. The MRSS team meet with youth and families in person wherever they are. All services are provided in a trauma informed way and utilize family systems intervention. Families can stay with MRSS for up to 60 days. Call for assistance 24 hours a day, 7 days a week. Hocking, Jackson and Vinton Counties call 740-656-6122

#### **School-Based Services**

HHC clinicians are In multiple school districts throughout our service area, HHC has counselors and CPST providers working in schools to provide services to youth. Service eligibility criteria are the same as for clinic-based services, but school-based services are often more convenient for consumers and allow a greater involvement from school personnel.

#### Infant and Early Childhood Mental Health (IECHM)

This team utilizes evidence-based therapeutic services for children aged birth -6 years of age and mothers with perinatal mood disorders. The team is trained in Child Parent Pscyhotherapy (CPP), Parent Child Interaction Therapy (PCIT) and Chid and Adult Relationship Enhancement (CARE) to provide high quality treatment in all 9 counties served by HHC The IECMH Team is a recipient of grants that allow the Team to also provide consultation in order to promote social emotional health, address challenging behaviors and wellness for children birth-6 years of age. This consultation takes place in homes, day cares, preschools, pediatric settings, WIC, recovery settings, Early Intervention teams and many more across Southeastern Ohio. #### REACH/Youth Day treatment - Cheshire, Nelsonville and Barlow

HHC's REACH program provides day-long treatment (Monday - Friday) for children ages 7 -17 experiencing severe emotional problems and having difficulty functioning successfully in their schools, families and communities. Programming involves educational, individual and group counseling, individual and group CPST, behavior management and skills building. Daily education is provided by the Educational Service Center. Transportation to and from home is provided. A psychiatric medical provider meets with children weekly (as needed). Separate treatment environments are provided for younger (7 - 11) and older (12 - 17) children. Cheshire REACH located 8323 St RT 7 Gallipolis, OH 45620, phone 740-445-3113.

#### **Psychiatry**

Although many individuals who receive behavioral health services can be treated with counseling or CPST alone, there are some problems which are more effectively treated with a combination of counseling or CPST and psychiatric medication (or with medication as the primary intervention). Severe depression, other mood disorders, many anxiety disorders, and thought disorders are examples of these problems. When needed, counselors and CPST providers can discuss the usefulness of an evaluation for psychiatric medication with their clients, and if the client is in agreement, a referral will be made to one of our psychiatric providers In severe or complicated cases, the psychiatric provider will continue to follow the course of medication. In less complicated cases, when the client's medication is stable, efforts are made to refer the client back to his/her family physician to follow the medication. In all cases psychiatric providers seek to coordinate treatment with primary care and other medical specialists

#### Substance Abuse Outpatient Programming for Adults and Children (Varies by Location)

HHC is certified by the Ohio Department of Mental Health and Addiction Services (ODMHAS) to provide substance abuse treatment services.

#### **Medication-Assisted Treatment**

Hopewell Health Centers provides medication-assisted treatment(MAT) utilizing the drug Vivitrol. Vivitrol, a long-acting injectable version of the drug Naltrexone, was selected as a more viable alternative to Suboxone (Buprenorphine),

Participants in the program may be experiencing legal problems, they also may have serious mental health needs, lack employment and transportation, are in overall poor health, homeless or deficient housing, and lack a recovery or pro-social support network. The treatment program is designed to addressall of these needs and provides participants with key wraparound services such as mental health and substanceabuse treatment, case management services, and healthcare.

#### **Outreach and Enrollment**
